#### **IMPROVING SAFETY**

- Explosive atmospheres are created by the presence of flammable gases, or dust-prone environments such as milk powder, fertiliser or animal feed stores.
- Electrical apparatus installed in these areas must be correctly specified, correctly installed and correctly maintained.
- This includes a hazardous area inspection regime, supported by documentary evidence (a hazardous area dossier).

# COMPLIANCE WITH REGULATIONS & LEGISLATION

- The Electricity Act 1992 and its supporting regulations are designed to ensure that everyone is working to achieve the minimum required safety standards when using electricity.
- The Electricity Act 1992 and the Health & Safety at Work Act 2015 are explicit about where responsibility lies to ensure the elimination or minimisation of risks. Directors, Officers and Managers are all responsible, and ignorance is not a defence.



### **IMPROVING SYSTEMS**

- We're all familiar with the phrase; "the job's not finished until the paperwork is done." An electrical installation must be supported by documentation to record the suitability of the equipment installed, the competence and qualifications of the installer, and the results of tests and inspections carried out.
- Entec can peer review a client's hazardous area dossier, carry out tests and inspections to populate a dossier, or indeed can build and manage a client's dossier from scratch.

## ADVICE AND TRAINING

#### CLEVER USE OF TECHNOLOGY

Entec has teamed up with CONQA to adapt its cloud-based QA system for use on our clients' sites. CONQA provides personnel working on installation, commissioning and inspection tasks with a smooth and efficient workflow;

- Inspection and Test Reports (ITR's) are available on a device (laptop, tablet or phone) when and where required.
- Documentation is completed at the time, and instantly recorded in the master QA system.
- Documentation is supported by date/time stamps, photos and any notes regarding remedial works.
- The records are kept in perpetuity, with future re-inspections added to the dossier.

Accuracy and efficiency are greatly improved by following this guided workflow. There are fewer bits of paper to handle (or lose), and QA is completed progressively rather than in a rush to clear the backlog at the end of the project.




#### **Project overview**

#### Folder structure

Navigate through a site, plant area and down to a section of process equipment, then down to an individual device. Green signifies "inspection completed and passed", red signifies "inspection failed, action required".



#### **Device overview**

Depicts the inspection tasks applicable for each device, together with the status of inspection on that device. Blue signifies "not applicable for this device type".



#### Inspection check-sheet

This guides the Inspector through their work-flow; they are prompted with each aspect to be checked. Where a "fail" is noted, the Inspector's comment is date/time stamped.
